Each of the bodies listed below are subject to the regulations of the Ralph M. Brown Act. All of these bodies are also subject to the Maddy Act (California Government Code Section 54970-54974). The Maddy Act requires that all seats that are scheduled to expire in the upcoming year be posted on an annual listing. This Act also regulates the posting requirements for unscheduled vacancies that occur throughout the year.

Planning Commission – Meets at 6:00 p.m. the 1st and 3rd Wednesday of each month. Four-year term.

Per OMC Sec. 10-1.02 Planning Commission appointments made after April 25, 2019 are appointed as follows:

The first Planning Commission seat to become vacant after passage of Ordinance No. 894 [April 25, 2019] amending this section shall not be filled. The second seat to become vacant shall be filled by the Mayor, and the third shall be filled by the Councilmember representing City Council District 4. Subsequent appointments shall be made in the following order: City Council District 1, City Council District 2, City Council District 3, City Council District 4, and the Mayor, repeating as terms expire such that the five Planning Commission members correspond to the Mayor and four City Council Districts. If a Planning Commission member resigns before the end of their term, the City Councilmember for the Voting District that appointed that member shall appoint their replacement.

The first voting Commission seat to become vacant after passage of the ordinance codified in this section shall be filled by the Councilmember representing City Council District 4. The second voting Commission seat to become vacant shall be filled by the Mayor. Subsequent appointments shall be made in the following order: City Council District 1, City Council District 2, City Council District 3, City Council District 4, and the Mayor, repeating as terms expire such that the five (5) Commission members correspond to the Mayor and four (4) City Council Districts. If a member resigns before the end of their term, the City Councilmember for the Voting District that appointed that member shall appoint their replacement.

Historic Preservation Commission – Meets at 5:00 p.m. the 2nd Thursday of each month. Four-year term

Per OMC Sec. Sec. 4-8.03 Historic Preservation Commission appointments made after September 25, 2020 are appointed as follows:

There is hereby established a City Historic Preservation Commission, consisting of five (5) members. Each Councilmember shall appoint one Commissioner, ratified by the approval of a majority of the full Council. While it is preferred that all members of the Commission have primary residence and be domiciled within the City, a minimum of three (3) members of the Commission must have primary residence and be domiciled within the City. All members must live within the Ojai Area of Interest, as defined by the Ventura County Local Agency Formation Commission. Members of the Commission shall be appointed for four (4) years on a staggered basis and shall hold office at the discretion of the Council until their successors have been appointed even if their designated term has expired. The first Commission seat to become vacant after passage of the ordinance codified in this section shall be filled by the Councilmember representing City Council District 4. The second seat to become vacant shall be filled by the Mayor. Subsequent appointments shall be made in the following order: City Council District 1, City Council District 2, City Council District 3, City Council District 4, and the Mayor, repeating as terms expire such that the five (5) Commission members correspond to the Mayor and four (4) City Council Districts. If a member resigns before the end of their term, the City Councilmember for the Voting District that appointed that member shall appoint their replacement. The designated terms of all members of the Commission shall expire at the second regular Council meeting of May.

Per OMC Sec. 4-16.101 Arts Commission appointments made after May 13, 2022 are appointed as follows:

Each Councilmember shall appoint one Commissioner in consultation with the Arts Commission Chair, ratified by the approval of a majority of the full City Council. The members shall be selected from among those in the community who have a special knowledge of and a demonstrated interest in the arts and who are interested in promoting such activity. In making such appointments, each Councilmember, in consultation with the Arts Commission Chair, may consider representation on the Commission from a number of arts-related disciplines and activities, including, but not limited to, the following: Performing arts, such as drama, music and dance; Visual arts, such as painting, sculpture, photography, graphics, video art and applied art; Literary arts, such as literature, poetry and journalism; Communications arts involving film, television and radio; Arts education, such as schools, libraries and community education; and Funding, such as fund raisers, representatives of public and private funding agencies and art patrons. No more than two (2) members of the Commission shall be nonresidents of the City.
