TREE PRESERVATION ORDINANCE: Prior to completing this application the applicant should review the Tree Preservation Ordinance (Sec. 4-11.01 through Sec. 4-11.13) of the Ojai Municipal Code, adopted September, 1999 by the Ojai City Council. The following items and information must be submitted to obtain a tree permit in the City of Ojai. Planning Staff may further require information in addition to these items should it be deemed necessary or appropriate under special circumstances.

ACKNOWLEDGEMENT: I understand that any permit that may be granted as a result of this request may be revoked by the City at any time. In consideration for issuance of this permit, I agree, and by use hereof, my agents, employees, contractors, agree to be bound by all of the provisions of Title 4, Chapter 11, of the Ojai Municipal Code, the Standard Conditions attached to this permit, and any special conditions hereon and attached hereto. I further agree to hold the City harmless (Sec. 7-1.105) from any claims, defense and legal costs, judgments for damages, or other relief against the city as a result of acts, or omissions, by me or my representatives, in the performance of any activities permitted hereunder, whether the condition giving rise to the claim or judgment was created in whole, or in part, by me or my representatives. Any inspection by the City shall in no way relieve the permittee from responsibility for the work. Applicant and Contractor are responsible with all compliance with all permit requirements, standard conditions, special conditions, and any other applicable requirements.

CONDITIONS PER CODE:

- Tree protection fencing is not recommended due to the small size of the construction site and limited potential impacts.
- All pruning or trimming activities for which a permit is necessary shall be performed by either (i) a certified tree professional who has been certified as, at a minimum, a "tree worker" by the ISA or a similar certifying organization

acceptable to the Community Development director, or (ii) under the direct field supervision of a certified arborist (Ojai Municipal Code Sec. 4-11.07).

- All pruning and trimming activities shall be performed in a manner consistent with ISA guidelines and recommendations. Excessive pruning or topping of trees is prohibited and may result in the assessment of tree replacement costs (Ojai Municipal Code Sec. 4-11.07).
- The name of the certified professional or supervising field arborist shall be provided to the City, along with proof of certification, prior to final authorization by the City and commencement of the tree work (Ojai Municipal Code Sec. 4-11.07).
- Climbing spurs and spikes shall not be used during tree pruning and trimming activities, except in cases of emergency, such as emergency utility work covered under Ojai, California Municipal Code Section 4-11.10 (Ojai Municipal Code Sec. 4-11.07).
- No chemical residues shall be disposed of within the drip lines of protected trees, including concrete washouts.
- Damage to roots shall be minimized. Roots encountered over 1 inch in diameter shall be cleanly cut perpendicular to growth (90 degree cut), rather than being left torn or crushed. Roots over 2 inches in diameter shall be avoided where possible or cut under the supervision of an ISA-certified arborist.
- An ISA-certified arborist shall be available on-call to assist with any concerns.

Note: Only electric-powered chainsaws are permitted within the City of Ojai. Any questions regarding the use of electric-powered chainsaws can be directed to Community Development Department staff at, (805) 646-5581 ext. 112.
